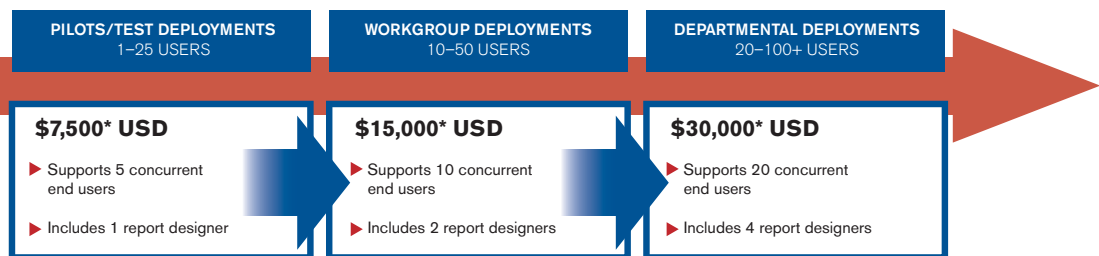
## Crystal Reports Server: Pricing and Licensing

### Pricing and Licensing: At-A-Glance

[Crystal Reports® Server](#) offers small and mid-sized businesses a complete solution for creating, managing, and delivering reports over the web.

### How Much Does Crystal Reports Server Cost?

The cost of your Crystal Reports Server deployment will depend on the size of the user base you plan to deliver reports to.

### What Am I Licensed to Do with Crystal Reports Server?

Regardless of the deployment size required, Crystal Reports Server includes all the components required to create, manage, and deliver reports over the web:

- **Report designer license(s) for creating reports**  
Each report designer license permits one named individual to install the Crystal Reports designer on a local machine to create reports. A single designer license cannot be shared among multiple individuals. If you require additional report design licenses, you can purchase Crystal Reports Professional, an enterprise report designer license.
- **Concurrent access licenses for end user report access and viewing over the web**  
A concurrent access license (CAL) is a simultaneous connection to Crystal Reports Server that allows an end user to access, view, and interact with reports using their web browser. A five CAL license, for example, permits five people at any time to be simultaneously connected to Crystal Reports Server for report viewing, printing, exporting, etc. If a sixth end user attempts to log on, he will be denied access until one person logs off. If an end user forgets to log off, his session will time out after X minutes (X is defined by the system administrator).

- **The right to deploy the system on one server machine with a maximum of four CPUs**

Regardless of how many licenses you own, you may deploy Crystal Reports Server on one single server that uses a maximum of four CPUs. This machine can be separate from the web application server. For deployment across multiple servers, [BusinessObjects Enterprise](#) is available for purchase.

Separate test and development environments also require standard licensing. There is no charge for a separate back-up or disaster recovery system.

- **One year of telephone support and maintenance for assured success**  
A single Crystal Reports Server deployment also includes standard telephone support and maintenance for one year. To access support, you are required to register the software and with Business Objects Customer Support. More details are available at: <http://support.businessobjects.com/programs/crserver/>.
- **Licensing for redistributing an application that embeds Crystal Reports Server**  
In addition to the licensing terms outlined above, if you would like to redistribute an application that embeds Crystal Reports Server to third parties, you must purchase a copy of Crystal Reports Server for each company you redistribute the application to. Additional Crystal Reports Server licenses can be purchased by each company for further scalability.
